## **Application Form for Admission to Acorns Nursery: 2 Year olds**

Acorns Nursery is able to offer places to children aged 2 years old, if they are due to turn 3 within that school year.

If you are eligible for 2 year old funding (15 hours per week), you **must** have a valid code from the local authority before your child starts, or you will be charged for the sessions. Funding can be used over 38 weeks of the year in line with current government legislation (term time only). Funding starts from the start of the **main term** after your child's 2<sup>nd</sup> birthday. To check eligibility, visit: **https://beta.bathnes.gov.uk/childcare-two-three-and-four-year-olds** 

Funding can be used for morning/afternoon sessions only – any lunchtime sessions attended are charged at £4.50 per day, <u>regardless of whether your child has a school lunch or brings a packed lunch from home</u>.

Places are subject to availability. Sessions **not** covered by funding are charged at £18.00 per session (£6.00 per hour). Invoices are issued at the start of each term and must be paid by the due date. Places are subject to review if invoices are not paid on time. **Applications must be for a minimum of 2 sessions over 2 days per week.**
